## THE PROCESS CONTINUED.



### Pre-Production

Multi-departmental meeting to implement and streamline the process necessary for production.



### Quality Control

Standard Sheet with specifications and set introduction to aid in the creation of the product.



### Scale-Up

The process team facilitate the scale-up from the development stage




### Procurement

The procurement department orders raw materials and packaging, with lead time being relayed via the Account Manager.

All Raw Materials + components are inspected to ensure they meet acceptable quality levels.

# WE CARE.

## THE PROCESS CONTINUED.



### Manufacturing

Raw Materials are picked, weighed and numbered according to the method of manufacture, then mixed into batches.

The batches are tested against specification and quality standards. Batch Codes and supporting documentation is prepared.

Batch Sizes – 10kg – 5 Tonnes



### Production

The components are taken to the line. The product bulk is run on the line into the components following the agreed instructions and procedures.



### Postproduction Review

A quality inspection is carried out for line approval, and throughout the run, samples are submitted for microbiological testing. Once approved products are packaged and palletised, dispatch notes are created and sent to you via the warehouse.


